



## **IATA Proposal for Chinese Customs Requirement**

The new requirements resulting from Chinese Customs Decree No 56, require airlines to provide some specific information to Customs for all shipments destined for China. These new requirements include <u>Shipper/Consignee Identification Code</u>, <u>AEO number</u>, <u>Specified Consignee Contact (Name & Telephone)</u> at the Master and House Waybill level.

In order to be compliant with these new requirements in a standardized way, IATA recommends the airlines to use the OCI segment. In order to meet these new requirements of Chinese Customs, below is the proposed format for OCI segment applicable to both Master and House Waybill.

The above proposal require amendment to IATA standard code list 1.100 Customs, Security and Regulatory Control Information Identifiers. IATA will take necessary steps to present this proposal to IATA Cargo Operation and Technology Board (COTB) and then adoption by IATA Cargo Services Conference (CSC) through Notice of Amendment Procedure.

It should be noted that airlines would require time to update their Cargo Management Systems for capturing the above information and then upgrade their Messaging Systems to transmit the above information to Chinese Customs.
